

## **SAN JUAN WATER DISTRICT NOTICE OF PUBLIC HEARING**

**NOTICE IS HEREBY GIVEN** that the Board of Directors of the San Juan Water District will hold a public hearing both in-person at the District Office, 9935 Auburn Folsom Rd, Granite Bay, CA 95746, and via videoconference in accordance with the Executive Orders N-29-20 and N-25-20 regarding the COVID-19 emergency, on the following dates:

Wednesday, October 14, 2020, at 6:00 p.m., or as soon thereafter as the matter may be heard. This public hearing will constitute the fourth and final public hearing of a series of four hearings the Board of Directors will hold pursuant to Elections Code section 10010 to receive public comments and input regarding the potential adoption of election division boundaries to elect the District's directors.

Concurrently with this notice, the proposed map of potential Board Member election division boundaries and the proposed sequence of division elections have been published. The Board will consider taking steps to adopt this map and sequence of division elections at the hearing.

All interested parties are invited to attend the public hearing and express opinions or submit information. The public hearing may be continued from time to time, as necessary, by giving notice at the aforementioned hearing.

**PARTICIPATION DURING COVID-19 PANDEMIC:** Due to State guidelines on physical distancing in public gatherings, the Boardroom can accommodate a maximum of 10 members of the public at one time. The District recommends that members of the public participate in Board meetings via videoconference per the instructions below.
