 5. Replacement machines must have a water factor of 4.0 or Less.

Terms and Conditions

1. The High Efficiency Washing Machine Rebate Program will be administered by the San Juan Water District with funding provided, in part, by Sacramento County Regional Sanitation District.
2. Washing machine must be purchased between **July 1, 2023 and June 30, 2024.**
3. **To be eligible for consideration for participation in the program:**
 - a. Property address where the high efficiency washing machine is installed must be located in the San Juan Water District retail service area.
 - b. Applicant must be the property owner and have an active water account with the San Juan Water District.
 - c. Replacement machines must have a water factor of 4.0 or Less.
 - d. Clear picture of the front of the clothes washer.
 - e. Purchase receipts are required and must show date of purchase, method of payment, and an itemized description of the washing machine.
4. Typically, an internet search of a machines model number will bring up the required water factor (WF or IWF) information (under product or technical specifications). If one cannot be found the Consortium for Energy Efficiency website at www.cee1.org can be used to locate the water factor.
5. San Juan Water District reserves the right to verify the purchase and installation location of any appliance for which a rebate is provided.
6. Rebate will be offered in the form of a bill credit.
7. Rebate program is subject to available funding. Rebates will be distributed on a first-come, first-served basis until funding is depleted. Submission of an application does not guarantee a rebate.
8. Only one (1) rebate will be given per household.
9. Applicant agrees to hold San Juan Water District, Sacramento County Regional Sanitation District (SCRSD), and Regional Water Authority (administrator of SCRSD's rebate program) harmless from any and all liability or claims for damage resulting from or alleged to result from (a) the installation of the washing machine, (b) the inspection of the premises to verify proper installation, and (c) any activity related to this program.
