3. Purchase and install eligible washing machine. Machines must be have a water factor of 4.0 or less.
4. Call San Juan Water District at 916-791-2663 to schedule your post-installation inspection.
5. Have the **completed application, your original dated receipt and water factor verification** ready for staff to pick up at the time of your post-inspection. Your receipt must be legible and show proof of your payment. Keep a copy for your records.

## Terms and Conditions

1. The High Efficiency Washing Machine Rebate Program will be administered by the San Juan Water District with funding provided, in part, by Sacramento County Regional Sanitation District.
2. Washing machine must be a qualified machine purchased between **July 1, 2019 and June 30, 2020**. Machines with a water factor of 4.0 or less are eligible.
3. Typically, an internet search of a machines model number will bring up the required water factor (WF or IWF) information (under product or technical specifications). If one cannot be found the Consortium for Energy Efficiency website at [www.cee1.org](http://www.cee1.org) can be used to locate the water factor.
4. To be eligible for consideration for participation in the program:
  - a. Property address where high efficiency washing machine is installed must be located in the San Juan Water District retail service area.
  - b. Applicant must be the property owner and have an active water account with the San Juan Water District.
5. San Juan Water District reserves the right to verify the purchase and installation location of any appliance for which a rebate is provided.
6. Applicant must allow SJWD staff access to washing machine for verification purposes. Staff may make recommendations for additional water efficiency measures that can be taken.
7. Your completed application form and your original sales receipt will be picked up by staff at the time of the indoor water audit.
8. Rebate will be offered in the form of a bill credit.
9. Rebate program is subject to available funding. Rebates will be distributed on a first-come, first-served basis until funding is depleted. Submission of an application does not guarantee a rebate.
10. Only one (1) rebate will be given per household.
11. Applicant agrees to hold San Juan Water District, Sacramento County Regional Sanitation District (SCRSD), and Regional Water Authority (administrator of SCRSD's rebate program) harmless from any and all liability or claims for damage resulting from or alleged to result from (a) the installation of the washing machine, (b) the inspection of the premises to verify proper installation, and (c) any activity related to this program.
