

**SAN JUAN WATER DISTRICT
NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the Board of Directors of the San Juan Water District will hold public hearings both in-person at the District Office, 9935 Auburn Folsom Rd, Granite Bay, CA 95746, and via videoconference in accordance with the Executive Orders N-29-20 and N-25-20 regarding the COVID-19 emergency, on the following dates:

Monday, August 3, 2020, at 6:00 p.m., or as soon thereafter as the matter may be heard. This public hearing will constitute the first of a series of four public hearings the Board of Directors will hold pursuant to Elections Code section 10010 to receive public comments regarding the transition of San Juan Water District from at-large elections for members of the Board of Directors to by-division elections for members of the Board of Directors, the time frame for this transition, the criteria and factors that should go into the drawing of maps of single-member voting divisions, the composition of the divisions, and other matters related to the election of members of the Board of Directors.

Wednesday, August 5, 2020, at 4:00 p.m., or as soon thereafter as the matter may be heard. This public hearing will constitute the second of a series of four public hearings the Board of Directors will hold pursuant to Elections Code section 10010 to receive public comments and input regarding the potential Director election division boundaries.

Following the second public hearing, draft maps of potential Board Member election division boundaries will be published and additional public hearings scheduled.

All interested parties are invited to attend the public hearing and express opinions or submit information. The public hearings may be continued from time to time, as necessary, by giving notice at the aforementioned hearing.

PARTICIPATION DURING COVID-19 PANDEMIC: Due to State guidelines on physical distancing in public gatherings, the Boardroom can accommodate a maximum of 10 members of the public at one time. The District recommends that members of the public participate in Board meetings via videoconference per the instructions below. The District does not transcribe its proceedings. Persons who wish to obtain a verbatim record of the proceedings should arrange for attendance by a court reporter. Such arrangements will be at the sole expense of the person requesting the recordation.

If you challenge the action taken on this matter in court, the challenge may be limited to only those issues raised at the public hearings described in this notice, or in written correspondence delivered to the Secretary for the Board at, or prior to, the public hearings.
