Worked with rural water districts to develop a map of potential ground water pollution sites within their boundaries and plan to protect their ground water sources from becoming contaminated.

Ad hoc committee of San Juan Water District consumers and Board members who met quarterly to discuss potential methods and communication for water conservation to residential and commercial consumers within the district.

San Juan Water District Rate Advisory Committee 2017

Part of a small group of residential consumers, agencies, and commercial users within the San Juan Water District who reviewed and provided feedback to the proposed rate increases beginning in 2017.

Hidden History Beneath Folsom Lake, 2016

Authored and published the book "Hidden History Beneath Folsom Lake" that focuses on the historic structures revealed when Folsom Lake was at drought water levels in 2014 and 2015. Particular attention was given to the North Fork Ditch Company that was the predecessor to the San Juan Water District.
